## Eligibility:

- ★ Indian citizen.
- ★ ISMPO member.
- ★ First /co-first or corresponding/co-corresponding author of an original article.
- ★ Age less than or equal to 45 years as on July 31, 2024.
- ★ The maximum age limit for applicants to the armed forces is 50 years as of July 31, 2024.
- ★ Original articles in Oncology and allied basic sciences (clinical, para clinical and basic sciences dealing with management of oncology patients) published efirst or print (whichever is applicable and earlier) in indexed journals (PubMed/Scopus/Web of Science/DOAJ) from November 3, 2023 to July 31, 2024

It should be accompanied with

- Latest PDF file of the published manuscript along with all the supplementary files, if any.
- AADHAR CARD/Valid Passport copy with clear name and birthdate visible.
- Undertaking that should the manuscript be withdrawn due to any reason, the award money will be returned back to ISMPO with a fine of INR 10000/- (Rupees Ten thousand only).

## Important points:

- ★ The awards will be given with a certificate, memento and a cheque in the name of the winner.

In case of any unforeseen circumstances when the winner is not able to attend, he /she should provide appropriate reason for the absence and nominate a co-author to receive the award. The said person will need to register and attend the ISMPOCON 2024.
- ★ If the winner/nominated co-author doesn't attend the ISMPOCON 2024, the award will be forfeited and be given to the next candidate from the merit list. The subsequent awardees will change accordingly.
